## Portfolio Description

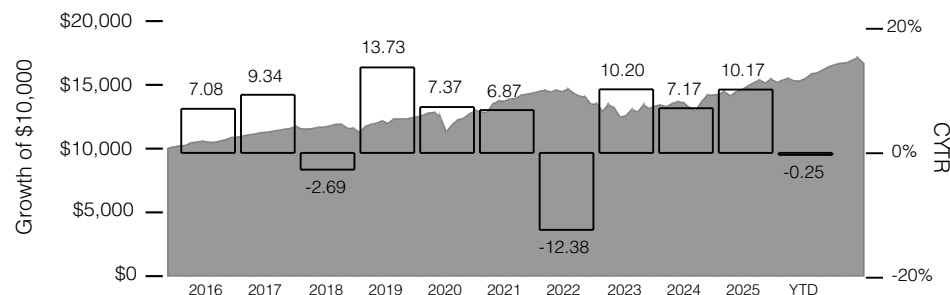
This Portfolio, the most conservative risk option among Thrivent's suite of Asset Allocation portfolios, looks to provide an income stream along with modest capital appreciation. It invests in higher-yielding, higher-risk, fixed income securities to generate income, and in equities to provide potential growth and income. Investments are diversified across sectors in order to manage risk and potentially provide more stability when interest rates fluctuate. The Portfolio is actively managed and invests in a combination of other funds managed by the Adviser and direct investments in equity and debt instruments. Prior to 4/30/2025, the portfolio was named Thrivent Diversified Income Plus Portfolio.

## Investment Strategy/Process

The Portfolio has a long-term target allocation of 80% fixed income and 20% equity securities. The portfolio management team actively manages the Portfolio with overweight and underweight positions in various sectors based on their views of the market and economy. Individual stocks and bonds are analyzed and chosen on an ongoing basis. The Portfolio is regularly rebalanced to ensure that the holdings are within appropriate ranges.

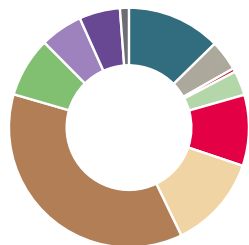

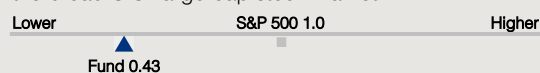
