The Portfolio invests primarily in equity securities of both U.S. and non-U.S. companies (including American Depositary Receipts and issuers in emerging markets).


Investment Strategy/Process

The portfolio management team strives to identify companies and industries that appear to have the potential for above-average returns or are expected to show above-average growth over the long-term, as well as those that appear to be trading below their true worth. They seek to build a portfolio with at least 80% of its net assets invested in the health care industry under normal conditions. The team conducts both industry and company analysis and considers a wide variety of factors including the political, economic and regulatory environments, growth drivers, margin trends, and the marketability of a company's products and services, as well as its competitive position, financial strength and valuation. As of April 30, 2023, Blackrock no longer serves as subadviser to the Portfolio.


