
Investment Strategy/Process

The portfolio management team seeks to achieve its objective by investing primarily in a portfolio of broadly-diversified equity securities of issuers throughout the world. The Portfolio has a long-term target allocation of approximately 80% international large- and mid-cap companies, 10% emerging market equity securities, 7.5% international small-cap companies and 2.5% cash and other securities. The Investment Adviser makes asset allocation decisions among the various asset classes.




