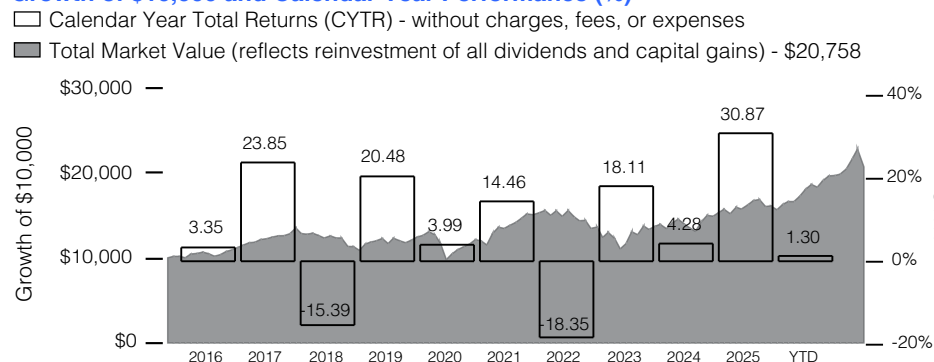
Portfolio Description

This Portfolio is a well-diversified portfolio of international securities, which includes companies outside of the United States. It's designed to provide investors with an all-in-one solution for international equity investing and includes allocations to large, mid and small-cap international companies, across the growth, value, and core investment styles. The Portfolio also provides exposure to emerging market stocks. Investors should be comfortable with the higher level of volatility that may be associated with international investing. Prior to 4/30/2025, the Portfolio was named Thrivent International Allocation Portfolio.

Investment Strategy/Process

The portfolio management team seeks to achieve its objective by investing primarily in a portfolio of broadly-diversified equity securities of issuers throughout the world. The Portfolio has a long-term target allocation of approximately 80% international large- and mid-cap companies, 7.5% international small-cap companies, 10% emerging market equity securities, and 2.5% cash and other securities. The Investment Adviser makes asset allocation decisions among the various asset classes.

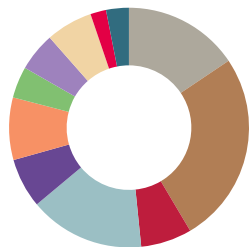

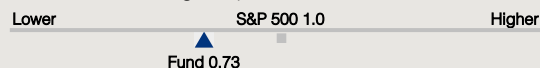

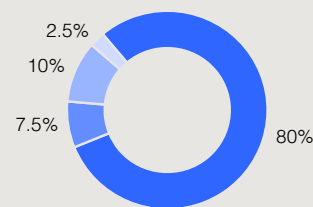
