## Portfolio Description

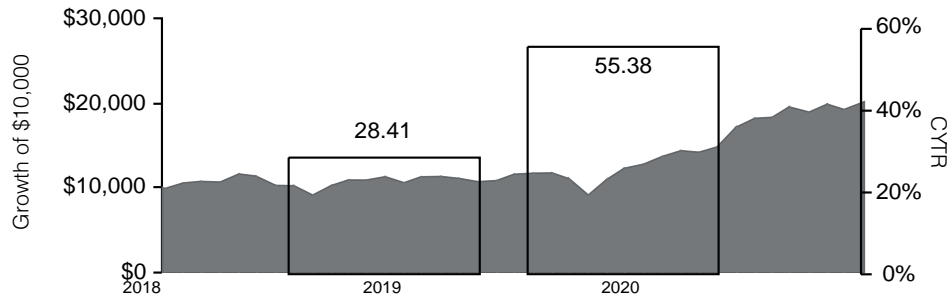
This portfolio seeks to provide investors with competitive performance through favorable stock selection while monitoring risk. The Portfolio typically invests in small-capitalization "growth" stocks. Growth stocks are companies whose earnings are expected to grow at an above-average rate relative to the market. Small companies may have the opportunity to grow more rapidly than larger companies as they potentially emerge from a small to a medium-sized company. However, they typically do not pay significant dividends to shareholders and instead reinvest earnings back into the company. Smaller companies have greater volatility (or more risk) because they are often less-seasoned, have narrower product lines, less liquidity, smaller revenues and fewer resources than larger companies.

## Investment Strategy/Process

The portfolio management team seeks to add value through stock selection and active management, and monitors risk in an effort to build a well-diversified portfolio. The team uses fundamental, quantitative, and technical investment research techniques to identify and purchase small companies that the team believes could grow their revenue and earnings faster than their peers, along with companies that could sustain growth over time.

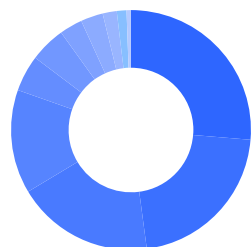
