### Five equity indexes

Thrivent offers five different index portfolios providing U.S., International and ESG exposure across the market capitalization universe. The domestic portfolios track the S&P SmallCap 600<sup>1</sup>, S&P MidCap 400<sup>2</sup>, S&P 500<sup>3</sup>, and MSCI KLD 400 Social<sup>4</sup> Indexes. The international portfolio tracks the MSCI EAFE<sup>5</sup> Index.

### Market replication

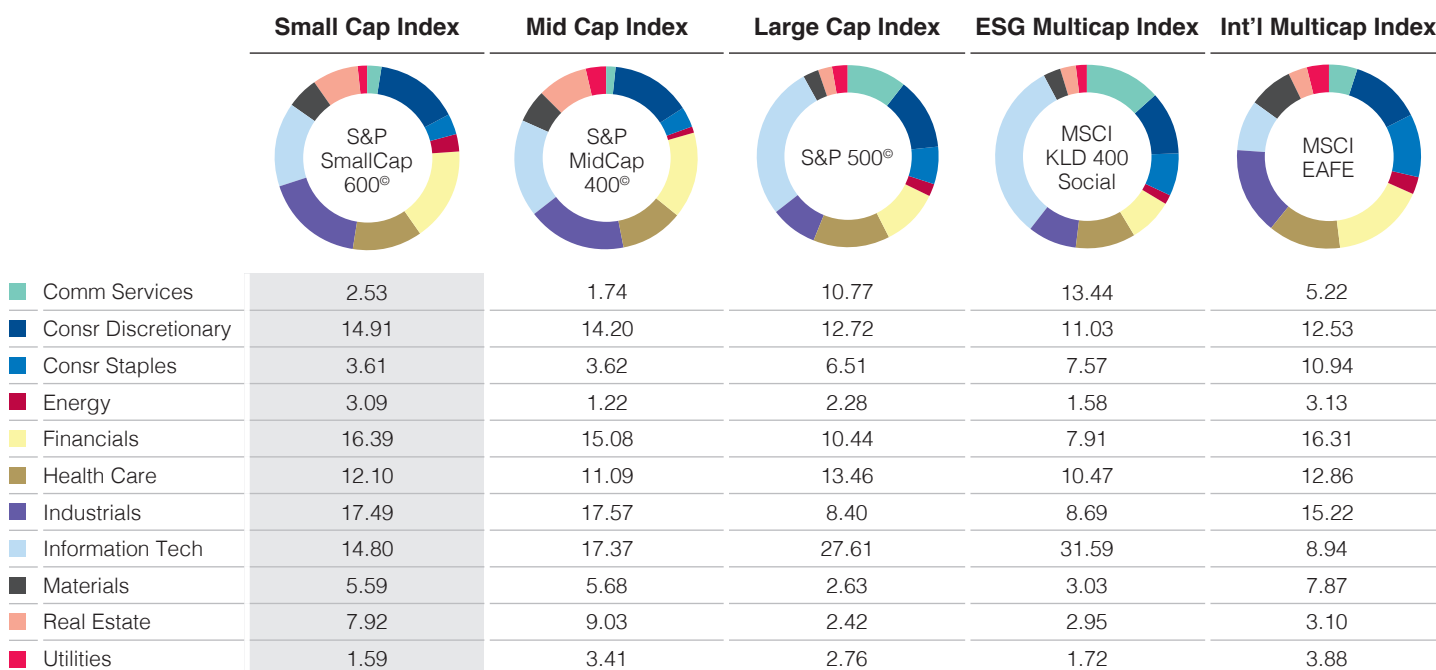
We utilize full replication for tracking the indexes. This means that each portfolio tracks the index by directly buying—in the same proportions—the underlying securities that make up the index.

### Broad market exposure

Combined, these five portfolios track approximately 90% of the U.S. market capitalization and approximately 85% of international market capitalization.<sup>6</sup> The index portfolios provide investors with an extensive amount of potential market exposure.
