

## Average Annualized Returns

This report shows performance as of the most recent month- and quarter-end for Thrivent Variable Portfolios.

All returns greater than one year are annualized; returns for periods of less than one year are not annualized.

Thrivent Variable Portfolios are only available to the public through a variable life insurance or variable annuity product. Performance data shown does not include any insurance or annuity charges, such as monthly or annual administrative charges, rider or additional benefits charges, cost of optional living or death benefits, percentage of premium charge, per unit charge, surrender charges, or cost of insurance chargers, which if included would lower the returns.
