## Fund Description

This Fund invests primarily in diversified portfolio of short-duration corporate bonds, asset-backed securities, mortgage-backed securities, U.S. Treasuries, and U.S. government agency debt. The Fund may also invest a portion of assets in U.S. dollar-denominated debt of foreign securities. The dollar-weighted average duration for the Fund is expected to be less than two years. The Fund's shorter duration makes it less sensitive to interest rate changes than some longer-duration funds. As a result, the Fund may be appropriate for an investor who is seeking the opportunity to generate a modest level of income (with some investment risk), but with less interest rate risk and a lower return potential than most longer maturity bond funds. The ETF is newly formed and has a limited operating history.

## Investment Strategy/Process

The portfolio management team seeks to add value by actively managing sector exposure and security selection, and by monitoring risk in an effort to build a well-diversified portfolio. The team uses fundamental and other investment research techniques to determine which debt securities to buy and sell. The Adviser generally focuses on issuers that it believes are financially sound and that have strong cash flows and earnings. The Fund may use an interest-rate management technique that includes the purchase and sale of U.S. Treasury securities and related futures contracts for the purpose of managing the duration of the Fund.

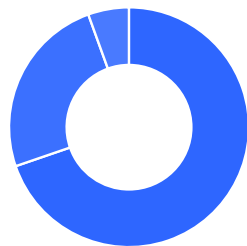
