## Fund Description


This Fund, the “mid-point” risk option among Thrivent’s suite of Asset Allocation Funds, is designed for investors with a medium to long-term time horizon and a moderate risk tolerance. The Fund is globally diversified across major equity and fixed income sectors. It’s actively managed and invests in a combination of other funds managed by the Adviser and direct investments in equity and debt instruments.

## Investment Strategy/Process

The Fund has a long-term target allocation of 65% equity securities and 35% fixed income. The Fund’s asset allocation strategy starts with the construction of a model that sets the long-term target allocations for the broad asset classes of equity and fixed income. Next, the target weightings for sub-classes are determined. Equity sub-classes are often based on market capitalization (large, mid, and small), investment style (such as growth and value), and economic sector. Fixed income sub-classes may be based on maturity, duration, security type or credit rating. The Fund may invest in foreign securities, including emerging markets. The portfolio management team actively manages the Fund with overweight and underweight positions in the various sub-classes based on their views of the market and economy. Individual stocks and bonds are analyzed and selected on an ongoing basis. The Fund is regularly rebalanced to ensure that the holdings are within appropriate ranges.




